Examples of violations of personal rights covered by the justification of the District Court in Warsaw, XXIV Civil Division of September 8, 2020 in Warsaw

case brought by Robert Szustkowski

against

Ringier Axel Springer Polska limited liability company based in Warsaw

*„ He is present in companies related to the immediate circle of Russian President Vladimir Putin (64). Robert Sz. 20 years ago he was the representative for Poland of the Assembly of Spec Bank, controlled by the Russian mafia", "Did the Russian mafia repeat the idea of cameras and wiretaps to blackmail Polish ministers a dozen or so years later? The prosecutor's office should explain this. However, so far, investigators have not questioned either Robert Sz. or his partners who run the restaurant!", „(...) and Robert Szustkowski, a businessman living in Poland, who already 20 years ago was doing business with leading KGB officers, close to the president himself Russia to Vladimir Putin. Szustkowski is also so respected in the Kremlin that he became charge d'affaires of Gambia in Russia, which most often enables the organization of common interests between countries.", "(...) his relations with the businessman Szustkowski, who conducts business with former KGB officers (...) ", "He says this about business with Robert Szustkowski, who has been cooperating with leading KGB officers, even close to Vladimir Putin (...)", "suspicious businessmen", "(...) whose shareholder was Robert Szustkowski, associated with the KGB and the Russian mafia", "For years, its shareholder was Robert Szustkowski, a businessman with Swiss citizenship, who in the past did business with former KGB officers and members of the Russian mafia", "(...) that Falenta was recommended to the Russians by the multimillionaire Robert Szustkowski, who has been has been doing business with them for over 20 years. Who is Szustkowski?", (...), Szustkowski is associated with people associated with the so-called the Sołntsevo mafia and the Russian intelligence service GRU. "In 1995, he was the Polish representative of Montazspecbank, controlled by the Sołntsevo mafia. His sports and rally passions were sponsored by Vnukovo airport, supervised by mafia oligarchs Andrei Skocz and Lev Kvetnoy," we read. Rzeczkowski indicates that the Sołntsevo mafia is "under the care" of the GRU and performs "special tasks" for it. "Szustkowski is also a mysterious businessman who appeared in many threads of the reprivatization scandal. Today, Ewa Domrzała loudly admitted that in their environment there were people associated with the Russian Sołntsevo mafia", "It was the Sołntsevo mafia that was supposed to pay Szustkowski for various services", "Szustkowski said that he earns about \$10,000 a month from the Sołntsevo mafia, that they they fund everything for him, that he doesn't spend anything, that he has nothing to do with the money. And that he would be happy to invest it in the company. Maciej and mine – she said, "Szustkowski has Kotas, and the Sołntsewski family has Szustkowski. Kotas is doing something with the army, his boss Szustkowski with the Sołntsevskys, the Sołntsevskys with the GRU. It is understandable that there are various suspicions and we all know what these suspicions are," "The Sołncewscy family stayed with Szustkowski almost constantly," (...) and Robert Szustkowski (founder of the Radius Group). The latter sued Fakt for suggesting cooperation with the Sołntsevo mafia. – Shustkowski has Kotas, and the Sołntsevskys (Russian mafia-ed.) have Shustkowski. Kotas is doing*

*something with the army, his boss Szustkowski with the Sołntsevskys, the Sołntsevskys with the GRU, "(...) regarding the past of one of the co-founders of the Radius group, Robert Szustkowski. In the past, the businessman was a Gambian diplomat accredited to Russia, and over the course of twenty years he was present in the companies of influential Russians linked to the mafia and people from the immediate environment of Russian President Vladimir Putin", "Who is Shustkovsky? According to at least two independent sources, from Falenta's point of view, the most important person in the Kuzbas puzzle was the multimillionaire Robert Shustkowski, who was supposed to recommend the businessman to the Russians. (...), Szustkowski is associated with the so-called Sołntsevo mafia and the Russian military intelligence GRU" - we read in "Polityka". As the weekly emphasizes, "for Marek Falenta, who wants to control the Russian coal market in Poland, it is difficult to imagine better protectors than Szustkowski and his friends." The businessman allegedly met with Szustkowski in Konstancin, "(...) in the companies of the Radius Group, a development consortium acquiring land in Warsaw and Sopot. Robert Jan Sz is also a member of the management board of this company. I am not revealing his name because there are facts incriminating his father, who de facto controls the Radius Group very serious", "People from the management of the Radius Group have connections not only with the Russian mafia, but also with the authorities of the companies that owned the Sowa i Wiedzy restaurant, where recordings embarrassing to PO politicians were made."*
